Article 2. Prices and Payments

- 1. All articles and/or services offered by Yellow Parts on this site are in euros and include VAT, unless indicated otherwise.
- 2. Payment to Yellow Parts can be made in the following ways:
 - Payment via Courier Service (cash on delivery)
 - Payment by bank transfer.
 - Cash payment upon pickup.
 - IDEAL
- 3. You can indicate how you wish to pay while completing the order. Rabobank bank account number: 10.58.60.050 in the name of Yellow Parts. Please mention your name.
- 4. Goods will be shipped when the total amount has been credited to Yellow Parts' account. If the amount has not been credited within 7 days, we will contact you.

Article 3. Shipping and Transport

- 1. You can choose the type of transport yourself. During the ordering process, you can choose from the following options:
 - Courier Service
 - Pickup in Druten
- 2. If you have a different choice, please contact us at 0487-511726 or mail to info@yellowparts.nl For further shipping information, please consult Yellow Parts' shipping conditions.
 - The shipment of goods is (unless otherwise agreed in writing) at the risk of the buyer.
 - If the buyer has entered an incorrect address, the costs are for the buyer.
 - If the buyer is not at home to receive the goods, additional costs will be charged.
